 - Ages 35+ No category restrictions

 - No category restrictions
- After a discussion, the NTC is recommending the following for a regulations update:
 - Mass Start Events, regardless of age, will require Cat 1/2/3
 - Sprint Event, regardless of age, will require Cat 1/2/3
 - No changes to the individual events
- Bonnie to review with Tara/Brian
 - o Any ramifications regarding attendance/backlash?
